Provisional Departmental recognition upto class VIII is hereby granted to the Halichild High school ~~19/10/78~~ by ~~V/V/V/V~~ for one ~~Year~~ Year with effect from 1.2.79 as very special case on the following conditions

1. Appointment of headmaster/Headmistress with at least 5 years experience if a B.T. or M.A. and 10 years experience if an untrained graduate.
2. Creation of a reserve fund of Rs. 2,000/- invested in N.D.C. or N.S.C.
3. At least 500 books in the library. Levy of a library fee of Rs. 2/- per pupil per annum.
4. Abundant use of Library books by pupils and teachers.
5. Adoption of a Library programme to ensure that every student reads at least 2 Library books every year.
6. Teaching and conduct of activities according to annual and terminal plans.
7. Promotion according to Departmental Rules.
8. At least 200 working days a year.
9. Improvement of teaching as to be reflected in the result of terminal and promotion examinations.
10. Due provision of co-curricular activities.
11. At least three terminal examinations the record of which should be systematically maintained for inspection.
12. Removal of the Defects as pointed in the Inspection Note.
13. Land at least Six bighas for instructional buildings and seven bighas for play ground.
14. Building at least semi-permanent commodious well adopted and hygienic.
15. No under qualified teacher in the staff.
16. One graduate teacher for each high school class section.
17. Constitution of the Managing Committee according to the type plan of the Departmental Rules and Orders.
18. At least 25 pupils in each class section and at least 75% pupils of each class section must be duly promoted.
19. Academic Deptt. Recognition is granted only to the yr. 1979-80.
